



## **RULES OF ENTRY**

**PLEASE READ CAREFULLY** – These rules are intended to ensure a safe, fair and fun-filled Competition, and must be adhered to by all entrants. Show and Competition Management is the final authority.

Entries close on Friday 8<sup>th</sup> November 2019 or once all places are full. Late or special entries may be accepted at the discretion of Competition Officials.

Entry fees must be paid in full at time of entry. Bank account details for payment are: BNZ 02-0139-0128519-00. Please use your Full Name as a reference.

Competitor Breakfast will be held at 7.30am with a Competition Briefing at 8.00am.

Preliminary rounds will commence from 8.30am.

Order and allocation of time slots for each Competitors 'run' will be selected by random ballot on the morning of the competition.

Any Competitor who is not onsite at the time their 'run' is to commence will be eliminated from the Competition.

The judging of each stage will be based on knowledge, skill, spacial awareness and timing. The final of the Competition will be held between the top 4 Competitors.

Prize giving will take place at 3:30pm. A trophy and cash prize will be given to the Competitor who is awarded 1<sup>st</sup> Place. The Competitors placed 2<sup>nd</sup> & 3<sup>rd</sup> will be awared a prize.

Each Competitor will be given an Entry Pack containing a 'Run Sheet' on the process and sequence of the Competition and full Health and Safety Documents.

All Competitors must be present for the Competition Briefing and draw of the random ballot to select the order of Competitors Time allotment. Practical clothing and Steel Toe Footwear must be worn at all times. Competitors must where The Turners Truck & Machinery Show T-Shirt supplied.

The MIMICO Excavator Competition in conjunction with The Turners Truck & Machinery Show is a family event, intended to promote and showcase the industry to the public.
